- Engage doctoral candidates, offer excellent feedback, and inspire candidates to achieve course and program outcomes relevant to dissertation
- Maintain contact with doctoral candidates via phone, video conferencing, and email through their dissertation sequence
- Attend the Research Proposal Defense and Dissertation Defense
- Work collaboratively with Program Director to ensure student engagement and success
- Participate in initial and ongoing training
- Candidates are not required to come to campus

- Knowledge of both quantitative and qualitative research methods

Timeline

Spring I

- Dissertation Readings: Meeting with doctoral candidates; provide effective feedback for the *early stages* of Introduction (Chapter 1) and Literature Review (Chapter 2)
- Comprehensive Examination: Provide feedback on the comprehensive examination questions; read and assess exam

<u>Summer I</u>

• Research Proposal I: Meeting with doctoral candidates; provide effective feedback for the *completion* of Introduction (Chapter 1) and Literature Review (Chapter 2)

<u>Fall I</u>

- Research Proposal II: Meeting with doctoral candidates; provide effective feedback for the completion of Methodology (Chapter 3); support doctoral candidates as they prepare for the Research Proposal Defense (RPD); attend the RPD; approve the doctoral candidates' applications for Institutional Review Board (IRB) approval
- Please note: Some doctoral candidates may not complete the RPD and IRB until spring II

Spring II:

- Dissertation Course: Meeting with doctoral candidates as they collect and analyze data; support doctoral candidates and provide feedback as they begin to write Results (Chapter 4)
- Please note: Some doctoral candidates may complete the RPD and IRB during spring II

Summer II:

 Dissertation Course: Meeting with doctoral candidates as they collect and analyze data; provide effective feedback for Results (Chapter 4) and Findings (Chapter 5); support doctoral candidates as they prepare for the Dissertation Defense; attend the Dissertation Defense; support candidate as they make final changes to dissertation and finalize requirements at College of Saint Mary

Fall II (if needed)

• If the doctoral candidate does not complete the dissertation in summer II, they will likely finish during Fall II.

If an additional semester is needed for one or more students, the chair and the program director will work out a plan for the student/s.

Pay

This position will pay one credit hour (\$1,000.00) per semester for three students. If one or more students discontinue work on their dissertation, the pay will be adjusted accordingly.
